## Event Competition Rules – 6 June 2026



Classes are run in accordance with Show Horse Council Australasia rules. For full rules please refer to [www.showhorsecouncilaust.com.au](http://www.showhorsecouncilaust.com.au)

**ENTRIES & PAYMENTS:** Close of entries is 11pm Thursday 4<sup>th</sup> June 26. All entries must be submitted via entry form – emailed to [ntshowhorseassoc@gmail.com](mailto:ntshowhorseassoc@gmail.com). Entrants, not members of NTSHA, must pay day membership of \$10.00. Classes cost \$7 per class for NTSHA members and \$9 for non- members.

**INSURANCE LEVY:** Equestrian Disclaimer is to be completed by all competitors and forwarded with entries.

**REFUNDS:** Refunds are subject to the production of a Vet or Doctors certificate stating that the horse/rider was suffering a condition that would prevent them from competing. Incorrect entries WILL NOT be refunded, and a \$20 administration fee will be charged.

**COMPETITORS:** All competitors compete at their own risk.

**PROTEST:** Any protest accompanied by a non-refundable fee of \$100 must be in writing, and handed to officials, within 15 minutes of the incident. Ruling on the protest by the NT Show Horse Association Committee members present at the show will be final.

**FEED & WATERING:** Whilst horses are on the Reserve the feeding and watering of them is the responsibility of the owner/exhibitor.

**HEALTH:** All horses must be free from contagious disease. Veterinary inspections may be carried out at any time and horses which, in the opinion of the Veterinarian, show signs of contagious disease, shall, if the organisers so order, be removed from the Reserve by the exhibitor at his/her expense.

**DRUG TESTING AND TREATMENT RULES:** It is the intention of the Drug Testing and Treatment Rules (Show Horse Council Australasia) all horses perform, at the time of competition, without any prohibited or banned substance/s within their system. A treatment sheet is required to be lodged to the NT Show Horse Assoc for any horse that has been administered any treatment, foreign substance, medication, drug, prohibited substance or banned substance, within 30 days of competition. Swabbing may be conducted on a random or for cause basis.

**ETIQUETTE:** Competitors at all times will display correct manners to judges and officials. Failure to do so will result in exclusion from the remainder of the Show and further action may be taken at the discretion of the organisers.

**ILL TREATMENT OF HORSES:** Ill treatment of horses will not be tolerated and will result in automatic disqualification from further competition.

**LEAD REIN and FIRST RIDDEN CLASSES** - a simple snaffle (egg butt or rings only) with a cavesson noseband must be used. A narrow strap may be attached to the front of the saddle. Reins must go direct from pony's mouth to the rider's hand, not be threaded through a monkey grip or obstructed in any way.

(a) Lead Rein – A leather lead rein to be held by the handler in the left hand and attached to the cavesson noseband. The handler may carry a cane not to exceed 40cm. The rider must **not** carry a whip and spurs are **not** permitted.

(b) First Ridden Classes – The rider may carry a cane **not** to exceed 40cm. Spurs are **not** permitted

**EQUIPMENT:** Saddlery must be in a safe condition to the satisfaction of the organisers, or the competitor will not be allowed to compete.

**TIMES:** Order of events shown in the program is a guide only. It is the responsibility of competitors to ensure they are ready for any event in which they are entering. The organisers reserve the right to vary the order and times of events as they see fit. Classes will not be held for competitors.

**CHAMPIONSHIPS:** The second-place getters in all classes that qualify for Champion must stand by, and the horse/rider that placed second to the horse/rider sashed Champion will be required for the judging of the Reserve Champion.

**MEASURING:** Measuring certificates are **not** required for this show. The Organising Committee has discretion to move horses between classes where appropriate.

**AGE OF COMPETITORS:** for classes determined by age, age is at the day of competition.

**ATTIRE:** Suitable/neat attire must be worn by all competitors. Any handler or rider, who, in the opinion of the organisers, is not properly attired, will not be permitted to compete. Helmets must be worn by all competitors under the age of 18 years.

**JUNIOR RIDERS:** Riders/Handlers under 18 years of age are not permitted to wear long boots in Rider classes and Smartest on Parade. This includes gaiters and chapettes. Junior Handlers must wear approved headgear in led classes.

**APPROVED HEADGEAR:** Riders/handlers Under 18 years of age must wear approved headgear to the current Australian (AS/NZ 3838; 1998 or European (EN 1384), or US (ASTNF 1163) standard. Riders 18 years of age and over are also permitted to wear bowlers and top hats.

**LED CLASSES:** Horses entered in breed classes MUST have been registered. However, registration does not need to be current or financial. Only horses that are not eligible for a specific breed class are eligible for the "Any Other Breed" class.

**CHILDS HACK and HUNTER CLASSES:** Rider must be under 18 Years.

**NOVICE HACK and HUNTER:** is one that has not been placed 1st in any Individual open ridden hack class at any Official Show. This Novice definition also applies to Show Hunter & Working Hunter horses in the relevant competition.

**INTERMEDIATE HACK, HUNTER and RIDER CLASSES:** is one that has not placed 1<sup>st</sup> Champion or Reserve in an Open Hack class/event at any Royal Show or has never been the Winner or Runner Up at the Grand National, received any State HOTY Title with 3 or more competitors, or has never been the Winner or Runner up in any HOTY Intermediate or Preliminary Title.

**HUNTER / HACK CLASSES:** Horses may only compete as either a Hack or Show Hunter **NOT BOTH**.

**STALLIONS:** Are not permitted at this event.

**JUDGES DECISION:** Judges decision shall be final subject to the outcome of any protest, report or investigation made with the Rules.
